Tuition Schedule 2023-2024

The following tuition structure will be in place for the school year 2023-2024. Please be aware that payment of tuition is absolutely necessary in order for the child to remain an actively enrolled student at Berean Christian Academy.

For first time students, applications are available in the office or can be downloaded from our website. The application and enrollment fees must accompany the returned application. The following items are required with the completed application: copy of a state-issued birth certificate, photo, and, if requested by the Principal, previous school's grades/transcripts and standardized test results.

The following tuition structure will be in place for the school year 2023-2024. Please be aware that timely payment of tuition is absolutely necessary in order for the child to remain an enrolled student at BCA.

TimeLine

JANUARY: Priority re-enrollment for current students.

New applicants may submit application forms which will be coded with the date of application. Preference will be given to those who submit application forms with the earliest date.

FEBRUARY 1: Enrollment opens to all. Newly-approved applicants will be placed in classes where there is space according to the order of application.

TUITION SCHEDULE:

Parents have three options in paying for their child's education while attending BCA. You may choose either a monthly payment plan, a semester payment plan, or a paid-in-full plan. All plans are outlined below:

MONTHLY PAYMENT SCHEDULE

Note: Monthly tuition is based on a 10-month plan (August-May) of monthly payments beginning on August 15. Each payment covers the following month. (i.e. Tuition received on August 15th is for the month of September.) **\$400 a month, \$2000 Semester payment, \$4000 paid-in-full**

Multi-child Family Discount

BCA does not offer a multi-child discount for families with less than 4 children. Part of keeping our general tuition low is making sure that every family pays the same amount. Additionally, we do not have tuition assistance or financial aid at this time.

Textbooks

Textbooks are provided free of charge to students in grades K-8. The enrollment fee of \$350 contributes to the cost of the student's curriculum.

Statement of Cooperation

I hereby make an application for my child to attend Berean Christian Academy (Grades K - 8) [hereafter referred to as the "School"]. In making this application, I understand and agree to comply with and abide by the provisions of the School Student Handbook and the rules and standards set out therein including, but not limited to, the following:

- 1. Berean Christian Academy has the right to dismiss any student who does not respect the School's academic and behavioral standards or does not cooperate in the educational process.
- 2. I agree to cooperate with the school policies and procedures and to pray for the school personnel. I agree to publicly support the school and bring whatever concerns I have to the proper individual as per school policy and procedures.
- 3. I agree to cooperate with the school's policy and dress code and understand I will be held accountable for my child's adherence to that policy.
- 4. I agree that my student and I will represent the school well. This includes behavior off-campus, in the virtual world and during school-sponsored activities such as field trips and sporting events.

Family Standards

Berean Christian Academy is a religious institution providing an education in a distinctly Christian environment, and it believes that its biblical role is to work in conjunction with the home to mold students to be Christ-like. On those occasions in which the atmosphere or conduct within a particular home is counter to or in opposition to biblical standards the school teaches, the school reserves the right to refuse admission of an applicant or to discontinue enrollment of a student. This includes, but is not necessarily limited to, living in, condoning, or supporting illegal activities, sexual immorality, homosexual acts or sexual orientation, gender identity different from one's biological gender, promoting such practices, or otherwise the inability to support the moral principles of the school (Leviticus 20:13a, Romans 1:27, Matthew 19:4-6).

Conciliation Clause Commitment

[Required for admittance to Berean Christian Academy]

The parties to this agreement are Christians and believe that the Bible commands them to make every effort to live at peace and to resolve disputes with each other in private or within the Christian church (See Matthew 18:15-20; 1 Corinthians 6:1-8). Therefore, the parties agree that any claim or dispute arising from or related to this agreement/enrollment in school shall be settled by Biblically-based mediation and, if necessary, legally binding arbitration in accordance with the *Rules of Procedure for Christian Conciliation* of the Institute for Christian Conciliation. [A copy of these Rules is available in the school office.] Judgment upon an arbitration decision may be entered in any court otherwise having jurisdiction. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement and expressly waive their right to file a lawsuit in any civil court against one another for such disputes, except to enforce an arbitration decision.
